SECTION 4. First aid measures

4.1. Description of first aid measures

Inhalation:

Air the area. Move immediately the contaminated patient from the area and keep him at rest in a well ventilated room. CALL A PHYSICIAN.

If breathing has stopped, give artificial respiration.

Direct contact with skin (of the pure product):

Take contaminated clothing Immediately off.

Wash immediately with plenty of running water and possibly with soap, the areas of the body that have, or are only suspected to have, come in contact with the product.

In case of contact with skin, wash immediately with water and soap.

Direct contact with eyes (of the pure product):
